Ending the production of internal combustion engines is an attack on the European industry!

The co-legislators have found а provisional agreement on the new CO₂ emissions' standards for cars and vans, which is one of the most controversial and dangerous regulations as part of the Fit-for-55 package. Indeed, this piece of will potentially legislation have а tremendous impact on the European industry because it will de facto end the large-scale production of internal combustion engines in Europe. According to the text, cars and vans producers must release only zero-emission vehicles on the market from 2035 onward, and that will bring about a massive production of electric vehicles, as the Commission has a notorious bias in their favour.

Unfortunately, the production of electric vehicles relies on value chains largely controlled by third countries, especially when it comes to the supply of raw materials but also in terms of expertise. Since China has built a solid leadership in the sector, we are afraid that this provision will oblige us to strengthen an already ongoing and controversial dependency on Chinese policies and decisions. On the other hand, we - Europe are leaders in producing internal combustion engines and we control their value chains as well. We do not understand why the Commission has been so blind in promoting such an unfair decision, while we should progress instead in the pathway of reducing CO₂ emissions of cars and vans by promoting the uptake of low-emission fuels and efuels that rely on the technology that we already master.

The EU's obsession with enlargement

Over the past decades, the EU has implemented a policy to support the gradual integration of the Western Balkan countries with the Union. Countries with current candidate membership status include Albania, North Macedonia, Montenegro, Moldova and Serbia. Bosnia and Herzegovina, Georgia and Kosovo have been granted the status of potential candidates.

The problem with the enlargement of the EU with most countries of the Western Balkans is, notwithstanding claims to the contrary by the EU elites, a complete lack of compliance with EU membership prerequisites.

These countries have failed to register any progress in reducing corruption and improving democracy. Figures published by Transparency International show a total lack of political will to tackle corruption. In fact, countries such as Albania have not improved their corruption and democracy record since 2014. Corruption is not the only issue in these countries, some of which have become major hubs in the global drug trade. Western Balkan organized crime networks are involved in heroin trafficking, cannabis production, the trafficking of cocaine from Latin America to the ports of Southern and Western Europe, migrant smuggling and prostitution. Not to mention that radical Islam and terrorism present a constant threat in these muslim-majority regions in the underbelly of Europe.

Despite the many billions of euros the EU has spent in the Western Balkans, independent organisations report that the situation in these countries is sliding back rather than moving forward. When even the European Court of Auditors raises questions over the effectiveness of the money invested in the Western Balkans, it is high time to put an end to the EU's obsession with enlargement.

Too late. Inefficient. Too rash. The Green Industrial Plan

With her Green Industrial Plan, EU Commission President Von der Leyen is reacting several months late to similar programs of the G7 industrial nations. Once again, however, she fails to focus on what is urgently needed. Officially sold as a response to the U.S. Inflation Reduction Act unveiled in August 2022, or to similar initiatives in Japan since May 2022 and in India even since March 2020. The 50,000 EU officials in Brussels have waited far too long to respond to conditions that have long been intolerable for domestic companies, such as subsidy rules that are far too tight or high-energy prices. The competitiveness of European industry has been declining for years. Helping them is the urgent priority.

However, the EU Commission cannot exclude Austrian showcase companies, for example in the field of highly efficient combustion engines.

The FPÖ can only support the proposal for an EU sovereignty fund promised for March if further joint new debts are ruled out from the outset and instead existing financial pots are used and savings are made in the right places. For example, there are still 220 billion euros in unspent funds left in the Corona recovery fund. In addition, the EU Commission must refrain from disbursing funds in a geographically uniformly wasteful manner using the watering-can principle. Instead, targeted strategic support needs to come from market-leading domestic companies.

Von der Leyen's claim to integrate more than three million migrants as part of the Industrial Plan and to push ahead with the controversial Mercosur Agreement, which has been rejected by numerous member states, is also completely out of place. In this respect, we see this initiative as clearly insufficient, too late and rash.

New CO₂ standards as a sign of divergent realities

During this plenary session a report is debated on the proposal to strengthen the CO_2 emission performance standards for new cars and vans. In short, it will put new ever-increasing demands on the European manufacturers for the proclaimed goal of climate neutrality by 2050.

The report claims that Battery Electric Vehicles (BEVs) are competitive in the long run when it comes to the total cost of ownership. If the total cost was lower for BEVs, then of course no regulation would be needed from the EU's side, as buyers are interested in saving money and would switch over without being forced to do so. But as it is, electric cars cost more, and what might be a "competitive" price in the eyes of the EU, would mean increased costs for the average European citizen. Considering the transportation options for people living in rural areas or small towns, especially families with children, a personal car is not a luxury item but a necessary mode of transportation. In times of increased inflation all across the EU, adding costly items to the family budget is just another sign of the divergent realities that the EU institutions and average Europeans live in.

Furthermore, car manufacturing is of central importance for the EU's economy and over 7% of the Union's GDP comes from it. The report claims that the new emission regulations "are expected" to even have an overall positive impact on employment. As the other parts of the world do not set such excessive regulations, it can be expected that the competitiveness of the EU's companies will decrease, which would be followed by more outsourcing of the plants to third countries. As the EU's big manufacturers in other sectors are already cutting down their production due to the times of crisis brought about by COVID restrictions and followed by the Ukrainian war, these new standards would only add to the weight already carried by the EU's economy and internal market.

It seems that no price is too high for the ideological green transitioners. Once again, the EU is looking for more ways of excessive regulation at the cost of the living standard of its citizens.


